

The Government of Belize (GOB) has reduced the Excise Tax on Diesel and Regular by close to 100% and 77%, respectively, but as global oil-price uncertainties persist, Belmopan is slowly running out of fiscal levers to pull to keep prices stabilized, economists Dr. Phillip Castillo cautioned this week. Speaking with The Reporter on Thursday, Castillo underscored that if international prices continue to climb, and with the excise on Diesel, for example, being practically already down to zero as the government seeks to keep the price locked in the \$13.00 range, the government may soon have no choice but to let the price at

"As I see it, I accept the dilemma," said Castillo. "I strongly support the mitigation measures. I realize that GOB has limited options. However, as those options are exhausted, they'll have to allow prices for Diesel and Regular to rise if the upward price trend continues globally."

Castillo, an economics lecturer at the University of Belize, indicated that government may be

he good news is that after three years of crippling Covid, Belize's economy (GDP) rose by 5.3 percent during the first quarter of this year.

The period January to June was the best half-year of all time, with exports of \$172 million, 11.7 percent better than the year before.

Belize tripled her exports to Mexico and doubled them to Central America. We produced a 100 percent increase in animal feed exports, a 119 percent increase in molasses sales, a 32 percent increase in marine foods (shrimp and conch and fish), and 16 percent improvement in citrus exports. This was offset by a 6 percent loss to the UK and the European Union.

The bad news is that inflation soared at an unsustainable 6.6 percent, according to the SIB's statistics for May this year. The problem was and continues to be, among other things, the war in Ukraine which has caused the price of fuel to go through the roof. The table below shows the problem:

Poultry Association warns that shop owners are taking advantage of egg price increase

This week, the Belize Poultry Association confirmed that the price of eggs has gone up on the wholesale and retail level, but warned that some shopkeepers are price gouging with the retail price.

The Reporter spoke with Poultry Association Manager Armando Cowo who explained that a handful of external factors forced poultry The increase in the cost of eggs is yet another commodity that Belizeans have to endure increasing prices on. The latest data provided from the Statistical Institute of Belize shows that inflation was as high as 5.3 percent for the first five months of 2022. The "food and non-alcoholic beverages" category with prices increasing by 5.4 percent, which saw

This data about economic performance and inflation were released recently by the Statistical Institute of Belize. However, the statistics only reflect what Belizean households have been feeling for months, as their dollar loses its purchasing power. This week, elsewhere in The Reporter there is yet another report of another commodity seeing an increase. This time is the Belizean early-morning favorite: eggs. producers to adjust the cost of eggs.

Those factors included higher fuel costs, fertilizer costs, and the cost of a key ingredient in animal feed called pre-mix. Cowo said that the pre-mixes are vitamins and minerals mixed into animal feed that are imported from Europe, which was already expensive, but the Russia/Ukraine war has made the situation worse.

A crate of eggs now costs \$105, working out to \$8.75 per carton or about 30 cents per egg wholesale.

"I am aware that some shopkeepers are changing a dollar for two eggs, which I believe is unwarranted," Cowo said. "If I am wholesaling you an egg for 30 cents, why would you sell it for 50 cents. You're making 20 cents. Not even the farmer is making 20 cents."

He went on to explain that the 30 cents wholesale per egg includes freight, transportation, feeding, and paying the workers on the farm. Cowo contends that shopkeepers don't have that kind of overhead. He also noted that Belize consumes a lot of eggs, which some shopkeepers have decided to exploit. consumers paying more for items such as meat, cereal products, cooking oils, seafood items, and fresh vegetables and fruits.

The cost of fuel was also up by 17 percent.

able to tinker with the General Sales Tax (GST) and Environmental Tax, but those are much smaller in terms of their impact. Additionally, the government, via press release, has already told the public that it cannot "afford" an "actual subsidy of the pump prices,' meaning that GOB will not "underwrite any portion of the import acquisition cost."

The Reporter also asked minister of state in the Ministry of Finance Senator Christopher Coye if this possibility was a concern for the ministry. "Yes, the Ministry of Finance is concerned about the continuing rise in acquisition costs," Coye replied, as he reiterated that the price is driven by external factors beyond local policymakers' control.

Coye, however, expressed hope considering that certain economic factors in the developed markets have helped to soften international prices more recently. "That said, while the Ministry of Finance is hopeful that that scenario [global prices coming down] plays out, it is still possible that the prices could reverse and start going back up again."

The International Outlook

Coye is not alone as it pertains to uncertainty regarding international prices. The US Energy Information A d m i n i s t r a t i o n (EIA)'s recent price forecast cites "heightened levels of uncertainty resulting from a variety of factors, including Russia's full-scale invasion of Ukraine."

Analysts are also highlighting that if the G7 countries implement the proposed cap on the price of Russian oil in an effort to limit Russia's oil-export revenues, this too could backfire. As reported by Business Insider, **RBC** Commodities Strategist Helima Croft admonished that such a price cap on Russia oil could lead to Moscow retaliating "by taking more barrels off the market abruptly to drive prices higher."

The Business Insider reports that, according to JPMorgan analysts, in that [reduced-Russian-oil] situation, oil could skyrocket to as high US\$380 a barrel, up from the EIA's forecasted

Acknowledging the probability of a worsecase scenario, Coye told The Reporter that the government continues to discuss with key "players in the fuel supply chain, specifically, the importer and the gas stations." According to Coye, the goal is to have these stakeholders share some of the burden by easing some of their charges.

"If successful, this would allow Government a little additional 'wiggle room' to accommodate even further increases in acquisition costs with the intent of maintain the current fixed prices on Diesel and regular gasoline," Coye shared.

Other Policy Options

Recognizing the unsustainability of the current fiscal measures, both Castillo and Coye were asked if other options, such as prioritizing targeted policies aimed at augmenting the service capacity, reliability, and quality of the public transportation system would have been more ideal.

"Government would certainly be open to considering other alternative options," Coye stated. "[As long as those options] do not further drain the already strained public purse, particularly, where they are targeted to those most adversely affected."

Castillo, citing some of the longstanding structural constraints in the public transportation sector, was initially less optimistic that even with robust government support and financing, remedies emanating from that sector would be doable within the short-term. However, the economist did concede that there may be some "merit" to an approach that focuses on strengthening public transportation so as to reduce the opportunity cost of commuters choosing the bus over their private vehicles.

For his part, Castillo also underscored that if conditions internationally worsen in terms of international prices, the government would be left with limited options. "It either will have to cut expenditures or borrow, or both."

relevant Ministry. Section 83(4) notes that if the officer continues to offend, then disciplinary action may be sought by a Chief Executive Officer (CEO), but that officer must first be informed in writing and given an opportunity to defend his/herself before the Public Service Commission gets involved to review the facts of the case.

Flowers explained that that entire process has been ignored, and instead, the government had placed Chi on Administrative Leave, an act for which Flowers say Chi has already been advised as having a solid legal case against the government.

Flowers also underscored the point that the allegations against Chi need to be reviewed. "Mr. Chi could have never hung up as he never had a phone in his hand," the PSU President explained. "The [Prime Minister] was on the phone with Chan's mother in law and the phone was on speaker. Chi's hands were occupied with the illegal species of plant."

"He simply refused to entertain the call and refused to take the phone," Flowers stressed.

Regarding the matter going before the Public Service Commission, Flowers explained that before anything happens, the Commission must communicate to Chi that a report has been received and request a response from him. In a previous interview, Flowers had described the idea that the Commission would

Procedure on minor misconduct.

83. A Chief Executive Officer or head of department shall issue an oral (1)warning to a public officer for minor misconduct under regulation 82(1).

If, after the oral warning a public officer's conduct does not improve, the (2)Chief Executive Officer or head of department shall warn the public officer in writing and the public officer shall, in writing, acknowledge receipt of such warning.

(3) The Chief Executive Officer or head of department may copy the warning issued under subregulation (2) to the Ministry.

Subject to subregulations (1) and (2), where a public officer fails to (4) improve his conduct, the Chief Executive Officer may recommend disciplinary procedures as follows -

even be considering disciplinary measures against Chi as "foolishness." Flowers had warned that dismissing Chi over the incident could have "serious financial consequences" for the government and people of Belize.

In mid-April, Chi had seized plants belonging to Diani Chan, owner of "Botanical Gardens by Roselyn" in the Corozal district. The plants reportedly lacked permits required under the Convention on International Trade in **Endangered Species** of Wild Fauna and Flora (CITES). During the exchange, Chan called Briceño who attempted to intervene and direct Chi to cease the seizure of the plants.

If the Commission determines that the officer has indeed consistently engaged in conduct that amounts to a minor offense, it has the option to impose a number of penalties which include: (i) caution; (ii) surcharge; (iii) fine; or (iv) suspension of increment. Alternately, Under Section (c), the commission may "refer the public officer to the following programmes (i) coaching or mentorship

programme; or (ii) employee assistance programme under regulation 206." Dismissal is notably

that it intends to support Chi in seeking legal action if he is unfairly dismissed, but warned that the lawsuit could be "very hefty."

Tour Operators Get Fuel Subsidy

With premium gasoline nearly hitting the \$18 mark and regular and diesel inching closer to \$14 per gallon, several tour and tender operators will be getting much-needed relief at the fuel pumps after they were granted fuel subsidies from the Belize Tourism Board.

The program, valued at one point \$5 million will run for a period of five months and will assist a total of 185 applicants, which represent micro, small. and medium-sized enterprises from across the country. On Thursday of last week, the BTB held a short ceremony at the Government House in Belize City to distribute fuel vouchers to the first 18 recipients and are hoping to distribute the remainder in the

across the country with some partial assistance in an effort to provide some sort of relief from the increase in fuel
prices that we are all suffering right now."

Castenada said that the program was a partnership between the Government of Belize which donated one million dollars and BTB which donated five hundred thousand. Castenada said that both entities were aware of the plight that tour operators are facing due to the increase in fuel and were of the view that more needed to be done to ensure the continued recovery of the tourism industry in Belize, in the aftermath of the pandemic. Castenada said that in April and May of this year the BTB distributed an application form asking interested tour operators to apply for the subsidiary if they were interested. In the questionnaire, applicants were asked to provide information on their fuel consumption levels for the past and future. Based on the figures submitted Castenada said that the BTB extracted those data to establish a figure on how the fuel subsidy would be distributed. That has resulted in a minimum fuel subsidy for tour operators starting at \$500 and then based on their consumption that fig-

ure would increase. Castenada, however, reiterated that they wanted to ensure transparency in the process and as such decided that no cash would be involved. Rather they have set up a fuel card system for tour operators to access at any Shell Gas Station around the county depending on where they are located. On a monthly basis, the recipient of these cards are only allowed to access a particular amount of fuel and once they surpass that amount then the account is locked off until the following month. For tour operators who do not have access to Shell Gas Stations, they are given vouchers that are assigned to specific gas stations in their area.

They too can only access a particular fuel limit for the month before their accounts are locked off.

But while tour operators are now able to benefit, Minister of Tourism Anthony Mahler said it did not come easy. "I prepared a Cabinet paper and took it to Cabinet. They said we couldn't do anything at that time. So, I doubled back and became more aggressive in my approach with regard to the help for the industry, and thankfully, my colleagues in Cabinet saw the reality. They could feel the reality and we devised a plan to help the country and the main sectors using transportation with some support." The government also assisted the Public Transportation Industry with fuel subsidy, while an increase in tariffs was approved for water transport. Currently, due to the increased cost of wheat and fuel, the bakers are also requesting assistance from the government.

In 1950, two years after the UN General Assembly adopted the Universal Declaration of Human Rights (UDHR), it created the United Nations High Commissioner for Refugees (UNHCR). The agency was to have three years to help the millions of Europeans who had fled or lost their homes during the Second World War, and then was to be disbanded.

Decades later, the UN Refugee Agency is still in business, and the number of displaced people in the world is over 68 million. Of that total, 25 million are refugees – people fleeing conflict or persecution – who have crossed an international border, while 40 million are displaced within their own country. The remainder are asylum-seekers – people who may, or may not, ultimately be determined to be refugees.

Article 14 of the UDHR grants the right to seek and enjoy asylum from persecution. This right, in addition to the right to leave one's own country (Article 13), and the right to nationality (Article 15), can be traced directly to events of the Holocaust. Many countries whose drafters worked on the UDHR were acutely aware that they had turned away Jewish refugees, likely condemning them to death. In addition, many Jews, Roma and others hunted by the Nazis had been unable to leave Germany to save their lives.

Under the umbrella of Article 14, more fully articulated in the 1951 Refugee Convention, over the decades millions of people have been given life-saving protection as refugees, been able to rebuild their lives and often have gone home again once the danger has passed. Many have also been resettled in generous third countries, where they use their skills to contribute to their new homelands. And some can settle permanently in the countries where they found refuge, like more than 170,000 Burundians who fled the country in 1972 and received Tanzanian citizenship in what is believed to be the world's biggest naturalization of refugees.

"We can't deter people fleeing for their lives. They will come. The choice we have is how well we manage their arrival, and how humanely."

risk their lives in unseaworthy boats, trying to cross the Mediterranean to Europe. Since 2014, every year at least 3,000 have lost their lives in this way, and in 2016 nearly 5,000 people died at sea. Many others perish during overland journeys.

People on the move are also at considerable risk from those who prey on their vulnerability, including state authorities who try to profit from, rather than protect, them, as well as unscrupulous people smugglers who treat fellow humans as highly profitable commodities as they try to circumvent land and sea borders.

"We commit to a more equitable sharing of the burden and responsibility for hosting and supporting the world's refugees."

Countries have the right to control their borders. However, as the UN has been pointing out for years, an orderly migration

system grounded in the human rights principles enshrined in the UDHR, would not only address countries' legitimate security concerns, but would also honour the rights that belong to both refugees and migrants.

In 2016, the 193 member states of the United Nations unanimously adopted the New York Declaration for Refugees and Migrants to protect those forced to flee, and support countries that shelter them. It paved the way for the adoption of two new global compacts in 2018: a global compact on refugees, and a global compact for safe, orderly and regular migration.

Many people who have clear protection needs, and leave their homes for reasons beyond their control, are not granted asylum because they do not fall under the accepted definition of 'refugee.' So-called 'climate refugees' are a good example of today's

The right to seek asylum is not unfettered. Article 14 makes it clear people cannot be granted asylum simply to avoid prosecution for "non-political crimes or acts contrary to the purposes and principles of the United Nations." So war criminals, and those guilty of a crime against the peace or a crime against humanity, do not qualify for asylum.

Cross-border displacement – including migrants, asylum-seekers and refugees – has become hugely controversial around the world in recent years. In order to exercise the right articulated in Article 14, people have to actually enter another country, and today countries all over the world are slamming the doors shut, keeping out refugees and other migrants with barbed-wire fences, walls and armies.






protection gaps and challenges. It is not clear how many people have been displaced across borders by climate change, but statistics on internal displacement are illustrative. The Internal Displacement Monitoring Centre estimates that from 2008-2016, weatherrelated disasters displaced, on average, 21.7 million people within their own countries every year. This does not include problems that build more slowly because of more insidious forms of climate change, such as rising sea levels, ground water turning salty, or farming and grazing land turning into deserts.

Similarly, people displaced by famine are in many cases not considered refugees within the definition of the 1951 Refugee Convention, or the various expanded forms of refugee protection. Yet clearly, they are in need of protection and assistance – and if they cannot get it at home, they have no option but to go abroad.

The Global Compact for Migration calls on countries to "cooperate to identify, develop and strengthen solutions for migrants compelled to leave their countries of origin owing to slow-onset natural disasters, the adverse effects of climate change, and environmental degradation." For such people not able to return to their home country, solutions envisioned in the Compact include planned relocation and new visa options.



n Thursday July 7th, 2022 on behalf of Hon. Rodwell Ferguson Minister of State for Youth, Sports, and Transport, who is abroad on government business and yours truly Hon. Gilroy Usher Minster of State for Youth, Sports, and Transport, this writer extended a warm welcome to the athletes, parents, and other invited guests at the Football Federation of Belize (FFB) in Belmopan for the awarding of over a dozen athletic scholarships to several Belizeans youths ,who have excelled in both their academic studies and football.

Police Officer Walks From Manslaughter Charge in the Death of Civilian

٦P L Kent ✓ Martinez, the police officer who was accused of fatally shooting Civilian Allyson Major Jr. back in 2019, during a high-speed chase in downtown Belize City, was acquitted of the charge in the supreme court on Monday of this week. Martinez was initially charged with manslaughter by negligence in Major's death; however, on Monday, the presiding judge Justice Ricardo O'Neil Sandcroft upheld a no-case submission presented by Martinez's lawyer,

Oscar Selgado, on the basis of insufficient evidence.

"There was no forensic or ballistic proof that what was removed from the brain of the deceased was what was fired from any of the firearms that were removed from the crime scene," ended Selgado.

But while one family celebrated the acquittal, the deceased family had to bear the burden of not being granted justice. Major's wife, Rhonda Major, told reporters that her family had been expecting the acquittal even before it was handed down. Major said that while the news was devastating for her family from the onset she did not have any faith in Belize's judicial system and worst had even questioned how the police would investigate one of their own.

In July of 2019, Major was shot and killed during a highspeed chase with police that ended at the foot of the Belize City Swing Bridge. At the time it was reported that Major had left his mother's house to purchase food for his children but instead was found minutes later with several bullets to the back of his head.

Police say that they had initially

Quite interestingly, Major's family had contracted the service of now police minister Hon. Kareem Musa who came out strongly against the excessive use of police force at the time.

EXCLUSIVE WTO faces new battle over COVID tests, drugs

GENEVA, July 7 (Reuters) - Less than a month after a hard-won deal was reached on a partial waiver of intellectual property rights for COVID-19 vaccines, a fresh battle may be looming at the World Trade Organization over extending the waiver to treatments and tests.

The June deal includes an agreement to debate waiving certain IP rights for tests and drugs, which the pharmaceutical industry says could lead to a broader unraveling of protections for treatments for other diseases

A group of six countries has set a sixmonth time frame for securing an agreement to extend the partial IP waiver, according to a document seen by Reuters.

"Extension of the policy tools... to therapeutics and diagnostics will help developing countries to address IP barriers to the expansion and diversification of production," said the document, backed by India, South Africa, Pakistan, Indonesia, Egypt and Tanzania.

"This will increase the accessibility of these crucial lifesaving COVID-19 tools."

The document, shared with other WTO members, foresees a decision by the WTO's top decision-making body, the General Council, in November or December. who declined to be named, adding some countries had agreed to the partial waiver only because of the possibility of it being extended.

PANDORA'S BOX? For opponents, the stakes are higher than ever.

Many COVID drugs and tests are also used for other diseases. Research from science information and analytics company Airfinity showed that 63 current COVID tests can be used for other infectious diseases such as flu, while 123 COVID treatment projects are being used for 95 other infectious diseases.

"It's a Pandora's box and sends completely the wrong signal for future pandemic preparedness," said Thomas Cueni, head of global pharmaceutical industry group IFPMA, adding it would undermine quality control and incentives for research.

"It is a coalition of countries who are fundamentally opposed to IP and they are trying to set a precedent to undermine (it)," he added.

Advocates said a broader agreement would be much more meaningful than the June deal that they argue is largely symbolic since demand for COVID vaccines has plummeted and many countries are destroying unused stockpiles.

Anna Marriott, policy

General Ngozi Okonjo-Iweala helped overcome the stalemate by calling for a parallel set of "quad" talks between four parties: India, South Africa, the United States and the European Union.

It remains to be seen whether she will use her convening powers this time. The debate over the vaccines waiver was at times acrimonious, with campaign groups and poorer countries heavily critical of wealthy countries.

The United States, which initially opposed the waiver but then switched positions, has previously indicated that it would only consider one limited to vaccines.

The Government of Belize reiterates the various steps Cabinet has taken to cushion increases in the imported price of fuel products, which has risen substantially as a consequence of, among other developments, the war in Ukraine.

Firstly, while the acquisition costs of fuel have increased more than 300% since November 2020, Government has substantially mitigated that increase by fixing prices on diesel and regular gasoline since March and dramatically reducing import duties on such fuels. At November 2020 and continuously for years before that, excise tax on diesel and regular gasoline was \$2.97 and \$3.29 per gallon, respectively. Today, those taxes have been reduced by virtually 100% and 77% respectively down to less than one cent and 75 cents per gallon.

Secondly, government has actively engaged with Puma Belize Ltd., the national fuel importer, to ensure that fuel product prices are the lowest possible prices. In addition, as a burden sharing effort, government is negotiating for temporary reductions to certain importer and dealer margins to allow government to accommodate even further increases in acquisition costs at the current fixed prices on diesel and regular

gasoline. Thirdly, government has expanded its fuel cost relief programs, originally including key foreign currencyearning sectors such as sugar and banana, to include tourism operators. Government is also now subsidizing the cost of public transportation. Naturally, as the import duties on fuel products have been reduced for everyone, the relative value to these sectors of these subsidies has dropped in tandem.

Year to date, the value of import duty reductions has totaled almost \$9 million. At this rate, by year end, budget funding from fuel duties will have been reduced by \$20 million. This represents a loss to government of \$55,000 per day.

So long as the imported fuel price allows, government will continue to hold diesel and regular gasoline prices at their current levels, in spite of the revenue losses. What government is absolutely unable to afford is an actual subsidy of pump prices: that is, for government to underwrite any portion of the import acquisition cost. Such a step would wreck the budget, put at risk public officers' salaries and pensions, adversely affect the provision of essential public services including health, education and social protection, and ultimately, flout a debt surge and devaluation.

The government will continue its engagements with stakeholders – consumer groups, the importer, dealers, and others – seeking to keep prices down, encourage efficiency and support targeted relief for key sectors.

G20 economies show restraint in use of trade restrictions amidst ongoing instability

720 economies continued to exercise restraint in the use of trade-restrictive measures despite increasing economic uncertainty aggravated by the COVID-19 pandemic and the war in Ukraine, according to the 27th WTO Trade Monitoring Report on G20 trade measures issued on 7 July. WTO Director-General Ngozi Okonjo-Iweala called on G20 countries, and WTO members at large, to show that the international community can work together to deescalate tensions and ensure a solid economic recovery.


"This report arrives at a time when the world

economy faces several challenges. As we continue to fight against the COVID-19 pandemic, the conflict in Ukraine has created a humanitarian crisis of immense proportions with serious implications for millions of people, especially with respect to their food security. It is in this context of economic and trade uncertainty that G20 economies must show restraint in implementing trade-restrictive measures and exercise leadership in supporting open and mutually beneficial trade," DG Okonjo-Iweala said.

The G20 Trade Monitoring Report makes reference to the recent WTO 12th Ministerial Conference (MC12) on 12-17 June, which secured unprecedented multilaterally negotiated outcomes.

"At MC12 we saw that, with the requisite political will, the international community can secure outcomes on a wide range of issues and react to the world's most pressing issues, especially when global solutions are necessary to respond to the pandemic and food insecurity, tackle environmental challenges, and foster greater socioeconomic inclusion. I urge the G20 to build on this momentum to de-escalate trade tensions to spur investment, growth and job creation," noted DG Okonjo-Iweala.

During the review period covered by the report (mid-October 2021 to mid-May 2022), the estimated trade coverage of the regular importfacilitating measures introduced by G20 countries (USD 581.5 billion) far exceeded the trade coverage of import-restrictive measures (USD 18.2 billion). The early part of the review period provided some encouraging news for a post-pandemic economic recovery, but the Omicron variant outbreak and the conflict in Ukraine had a significant impact on trade flows as result of specific trade-related measures adopted in response to the crises. The Omicron outbreak saw COVID-19 cases and deaths rise sharply in the first quarter of 2022 and, more recently, stringent lockdowns in China disrupted production and trade at a time when supply pressures appeared to be easing. The report indicates the lockdowns could lead to renewed shortages of intermediate and final goods, aggravating supply chain problems and inflationary pressures. During the review period, twelve COVID-19 measures on goods were communicated by G20 economies, primarily amendments of existing measures originally implemented in the early stages of the pandemic or the termination of others. Similarly, the flow of new COVID-19-related support measures by G20 Con'td on pg. 13 economies to mitigate

the social and economic impacts of the pandemic significantly decreased

over the past seven months. In the services sectors no new COVID-19-related measures were reported during the review period, but many measures introduced in 2020 were still in force and others were extended.

Since the outbreak of the pandemic in early 2020, 156 COVID-19 trade and trade-related measures in goods have been implemented by G20 economies. Of these, 113 (72 per cent) were of a trade facilitating nature, with an estimated trade coverage of USD 111.8 billion. Forty-three (28 per cent) could be considered trade restrictive with an estimated trade coverage of USD 95.7 billion.

Export restrictions accounted for 93 per cent of all restrictive measures implemented, and more than half of them were phased out during the review period, meaning that 19 export restrictions remained in place.

The war in Ukraine was another factor weighing on trade during the review period. The Secretariat identified 14 export restrictive measures put in place by five G20 economies during the review period in response to the conflict. These included quotas, temporary bans, or technical and administrative requirements limiting exports (or re-exports) of a wide range of agricultural commodities such as wheat, cereals, sunflower seeds, sunflower oil and other vegetable oils, soybean products, sugar, and flour. Various fuel products and fertilizers were also subject to export restrictions.

In addition, eight import facilitating measures adopted by ten G20 members were identified by the Secretariat during the review period in response to the conflict, including the reduction and/or elimination of import tariffs and other duties as well as the removal of import quotas on various agricultural commodities (including wheat, rice, flour, edible oils, cereals, and meats) and on fuel products. Five G20 economies suspended tariffs on all imports from Ukraine.

According to the Secretariat's preliminary estimates, the trade coverage of the export restrictive measures taken by G20 economies in response to the conflict (excluding sanctions), was estimated at USD 52.2 billion. The trade coverage of import facilitating measures was at USD 28.7 billion.

The report also refers to 43 specific trade and trade-related sanctions in the area of trade in goods, and 36 in the area of services, imposed on the Russian Federation by G20 economies. In the area of intellectual property, several G20 economies implemented measures and sanctions that might indirectly affect the maintenance and licensing of intellectual property rights (IPRs).

Overall, the Trade Monitoring Report notes that the stockpile of G20 import restrictions in force has grown steadily since 2009 – both in value terms and as a percentage of world imports. By mid-May 2022, 10.9 per cent of G20 imports were affected by import restrictions implemented by G20 economies since 2009 and which remain in force.

With regard to trade remedy initiations, the average number in the reporting period was the lowest since 2012 after reaching a peak in 2020. The report indicates that trade remedy actions remain an important trade policy tool for G20 economies, accounting for 46% of all non-COVID-19 related trade measures on goods recorded.

The WTO trade monitoring reports have been prepared by the WTO Secretariat since 2009. G20 members are: Argentina; Australia; Brazil; Canada; China; the European Union; France; Germany; India; Indonesia; Italy; Japan; the Republic of Korea; Mexico; the Russian Federation; Saudi Arabia; South Africa; Türkiye; the United Kingdom; and the United States.

Geovanni Brackett

Former COLA President Geovanni Brackett is the new information consultant operating out of the Office of the Prime Minister (OPM), a leaked memo written by Financial Secretary Joseph Waight confirmed this week.

A Balanced and Evidence-based Approach to Minimum Wage Adjustments

As the conversation on a minimum-wage adjustment develops, it is good that all stakeholders agree—even the business community, as articulated in a recent interview with the Belize Chamber of Commerce and Industry (BCCI)'s President—that an uprate to the minimum wage is necessary.

Additionally, most stakeholders appear to agree that the best way to approach it is by having a minimum-wage-adjustment formula serving as the guide post. That is also a good thing.

The agreement in those two BROAD areas is a great start. However, there are a few technical things that must be highlighted.

BALANCED AND EVIDENCED-BASED

Let's start here. The likes of the International Labour Organization (ILO) have advised that a Balanced and Evidence-based Approach (BEA) be employed when making uprates. What's a BEA? Simply put (and is consistent with the ILO's Minimum Wage Fixing Convention, 1970) is for policymakers to consider the needs of workers, the conditions of the economy, and the ability of enterprises to actually afford the increase.

Candidly speaking, policy always has to consider, inter alia, the ability of the regulated entities to comply with the change. This is why, no one—with a straight face—has uttered that the minimum wage should increase to something like \$20 per hour.

More precisely, the ILO, in its minimum wage policy guide, puts it like this:

"A balanced approach is one that takes into account, on the one hand, the needs of workers and their families and, on the other, economic factors.

"Such an approach combines both social and economic factors in order to find a level that benefits workers and society WITHOUT PROMPTING NEGATIVE EFFECTS. A balanced approach is necessary because a minimum wage is a redistributive tool that has both BENEFITS and COSTS.

"If set too low, minimum wages will have little effect in protecting workers and their families against unduly low pay or poverty. IF SET TOO HIGH, minimum wages will be poorly complied with and/or have ADVERSE EMPLOYMENT "potential" and "could." This area of economics is still evolving and many times the results are inconclusive across disparate research works. Nevertheless, there is value in keeping these adjustment channels in mind, as we discuss adjustments to the minimum wage.

Additionally, it is clear that not all of those eleven CoAs are "bad." Now! Which of those 11 CoAs will dominate in Belize? Well! That should be the subject of our own idiosyncratic research. Remember. Each economy is like fingerprints: Unique, and thus requires unique, research-based attention.

THE FORMULA

The CoAs and the need for a balanced approach are, among other things, the key motivators for a formula-based approach to be utilized. Countries such as Costa Rica employ a formula that looks at the consumer price index (CPI)'s changes alongside the state of the economy, while still preserving the indispensible role of the social partners.

In other jurisdictions, other variables such as the poverty line, productivity measures, and more have been incorporated into their formula in an effort to balance the needs on both sides of the labour market.

Most importantly, the formula-based approach is more predictable, frequent, and structured.

Hypothetically speaking, if since 2012, a formula had been utilized to guide changes on either an annual (or biennial) basis, and those changes were incremental, it is likely that the conversation TODAY would NOT be about jumping from \$3.30 to \$5.00, which is a significant 51% increase that already struggling employers would have to find! Considering the inflationary times, that pill would be a lot for micro, small, and medium-sized enterprises (MSMEs) to swallow virtually overnight.

If this process had benefited from more frequent updates (annually or biennially), then change might have been well below a 10% uprate (as opposed to more than 50%). Too sudden of a shift may summon the more negative members of that eleven-point list of CoAs mentioned above.

MEDIUM-TERM STRATEGY

For this reason, the ILO's advice on mediumterm MW strategy is also instructive:

"Many countries have discovered that a GAP exists between the legitimate needs of workers

sector's ability to pay cannot be ignored. ROLE OF SOCIAL PROTECTION PROGRAMS

Of course, the retort can easily be the old adage: "While the grass grows the horse starves." Can a responsible set of policymakers truly implement a judicious set of incremental increases to the minimum wage, while believing (or maybe even confirming) that the needs of workers are much higher?

The short answer is "no." But then, at this point, it becomes a debate on responsibility sharing. While, yes, the workers should benefit more from their work via higher wages, in the interim this is where governments must step in with social protection and assistance programs that, among other things, help to fill the remaining "gap." The minimum wage, therefore, cannot be the chief and only poverty-fighting strategy of policymakers; there is urgent need for other social protection programs to be upgraded or introduced, and these include "graduation programs," rent assistance initiatives, and more.

Graduation programs are worthy of some special attention. These types of social protection programs tend to include cash transfers to individuals or households (e.g. the individual may receive a stipend). Simultaneously, the beneficiaries are (mandatorily) enrolled in skills training programs, and thereafter are matched with productive employment opportunities. Fundamentally, at the end of a prescribed period of time, the participant should be able to stand on his or her own two feet either as a productive employee or an entrepreneur, and may very well be earning more than the legislated minimum wage.

To conclude, then, we must not lose sight of the real problem that we're trying to address: Poverty. Do minimum-wage adjustments help (however little) ease poverty? The empirical literature says, "Yes." But is this the only and permanent solution? From an inclusive growth and development point of view, the answer would be "no." Initiatives like "Graduation Programs," if done correctly, and in tandem with other robust social protection institutions, can help individuals climb socially and beyond minimum-wage levels.

CHANNELS OF ADJUSTMENT

Before proceeding, there is value in discussing these "effects" alluded to by the ILO and others, as there is a need to expand the paradigm on this subject.

Frankly, the economic literature on MW changes has long since moved towards recognizing that there are many likely channels of adjustment (CoAs) associated with an MW change.

As pointed out by economists such as John Schmitt (2013) and Hirsh et. al (2015) there are POTENTIALLY multiple CoAs. Schmitt, for his part, identified at least ELEVEN that COULD follow an MW increase. These are: (1) Reduction in hours worked, (2) Reduction in non-wage benefits (bonus, health insurance, pension contributions), (3) Reductions in training, (4) Changes in employment composition, (5) Higher prices, (6) Improvements in efficiency, (7) Efficiency wage response from workers, (8) Wage compression (slower increases for non-MW workers),


(9) Reduction in profits, (10) Increase in (consumer) demand, and (11) Reduced turnover. Now, please notice the use of the words and their families and what the ECONOMY IS CAPABLE OF PAYING IN TERMS OF MINIMUM WAGES. It will NOT be possible to eliminate this gap in a SINGLE MINIMUM WAGE ADJUSTMENT, at least NOT WITHOUT ADVERSE ECONOMIC EFFECTS."

"This suggests that there should be a mediumto long-term target for this policy – that is, closing this gap in SUCCESSIVE, GRADUAL adjustments."--ILO (2016, p. 52, at Link 1).

In order for there to be a "gap" there has to be two sides: In this case, workers and employers. Often, the conversation on minimum wage ventures into decreeing that the needs of the workers are at least \$5.00, \$10.00 or more. And, from a cost of living standpoint, that may very well be true!

However, the other half of that GAP is whether the average micro, small, and medium-sized enterprises (MSME) can currently afford to fill those gaps practically overnight.

In short, then, the balanced and evidence-based approach is not an attempt to relegate or ignore the financial needs of workers in any economy. Instead, it rightfully recognizes that there are literally two sides of the equation, and the private

The British Legacy Pt. I

The USA followed France in getting rid of aristocracy and the people voted for their president, their representatives in the House and the Senate (not Lords) and for some other public posts such as Governors of a state - well renowned democracy! The Latin American countries are all Republican States but unlike the parliamentary democracy, there is a very wide degree of variation. In most of these Republics there are a relatively few people of European extraction at the helm from colonial times who are "rotten rich" and who own everything while the vast majority of the population, who are the indigenous people, are kept as poor and destitute peons. Many of their leaders are corrupt dictators such as Samosa of Nicaragua who was killed, Batista of Cuba who had to flee in exile, Peron of Argentina, Fuentes of Guatemala and others who are military dictators that refuse to demit office. Coup d'état is common place here. This is distinctly not the case in Parliamentary Democracies. Thus many poor people from these Latin American countries move out from their more developed countries to little non-developed Belize.

There are constant and steady migrations from their own homeland. Central Americans have been pouring into little Belize over the years, people from El Salvador, Honduras, Nicaragua, and especially Guatemala (all larger except El Salvador). They are more developed and vastly more populated than Belize. This has been putting stress on Belize's social services e.g. education, medical, immigration, police, housing, lands etc. and it is also negatively impacting our fishing industry.

Several of the commonwealth countries have decided to relinquish the Queen as the Head of State (HOS) represented by the Governor General. When they have done this they appoint a President as HOS and they call this a Republic. But that President was not elected and they are really still a Parliamentary Democracy. Nothing else is changed: Same person who was GG or PM now called President. Same Leader of the Opposition, same Speaker of the House, same Mace Bearer, same Representatives, same Senators...except the Head of State is not the Queen. It amounts to really a macho nationalistic expression not necessarily a realistic change in governance. How many of the independent countries are truly better off socially today than when they were dependencies? Many former colonies that were small and lacked much resource want to show that they are truly completely independent and supposedly nationalistic and have sought to replace the Queen and inserted their own national HOS. But while this is so Caribbean island countries

heading for war with Germany just some eight years later, she initiated her claim and threatened to invade. Britain responded and established a garrison in Belize in 1945. Were it not for the British solders present in Belize, Guatemala would have taken over Belize with us as second or third class citizens languishing in poverty

like Barbados, Trinidad, Jamaica don't have a Guatemala claiming and threatening them like Belize does. If Belize copied Barbados and the British said:" OK we will withdraw our BATSUB" will Barbados replace them? One needs to realize that it was the British that protected us for over 80 years after Guatemala reneged on the 1859 Treaty that they signed with Britannia. A treaty which they reaffirmed some seventy years later and together with Britain put up the three boundary markers along the western border. But when Guatemala realized that Britain was

In reality there are about four different government systems in the world: (1) The Republican System, some of which are from the onset oligarchical (government by the few) that oppress the common people, some are from Coup d'état with military dictators ruling a vast majority of destitute citizens. (2) Communism which is absolutely socialistic with the state owning and running everything. (3) Fascism, a brutal system with little or no regard for its citizenry. Different brutal dictatorships in which rulers literally dictate on everything with laws enacted to suit. (4)The **British Parliamentary** System in which there is true and stable democracy. Former colonies who seek to obtain their independence do not themselves have any system of their own or seek to develop their own; they only look to the different systems already in existence and select one. The United States has a democracy which was well worked out after they fought for their own Independence from Britain. Still, if a president is unpopular and not suitable to the vast majority of people, the people have to wait four years to vote him/her out. On the other hand if he happens to be a most outstanding competent individual and fairly young, he has a limit of only two 4 year terms or eight total years in office. In the Parliamentary System, if a PM is deemed unsuitable he does not have to serve out his term of five years. The Parliament can move a motion of no confidence in him and vote and remove

him before his term expires. He therefore has no guarantee that he must remain for a full term of office. On the other hand if a PM is really good, he can be voted in again and again and again if he continues his good works and is not incapacitated in any way. This system is the most stable and solid one of them all and we along with all the other commonwealth nations are blessed with it. We in Belize like what we have and have enjoyed such a system of government. Let us therefore preserve it and keep it for our off springs to enjoy.

Independence is not a nationalistic event, but more importantly it is how citizens of the country live; i.e. their standard of living, their quality of life. If a people are totally "independent" but their education system is decadent, roads and communication services are poor, if they are unable to get farm produce to the market, to get the sick quickly to the hospital or to get the police to a crime scene or the fire service to a fire, if medical services are poor and inadequate, housing dismal or crime and poverty rampant etc.; then nationalistic independence is almost pointless as with the indigenous people of Central America who just want to get out. Compare this to a situation of some dependence where the standard of living or the quality of life is good plus a people are safe and secure, then this latter situation is preferable. For example, consider the Cayman Islands; their quality of life is far superior to very many independent former colonies. These are things to consider when making national changes.

Fun Facts! Does flying dehydrate you?



While technology and human ingenuity have unlocked our ability to travel across the world in recordtime, hurdling through the air above Earth's protective ozone layers is not exactly natural for the human body.

So, when you fly, your body experiences several challenges. One of those challenges is maintaining proper hydration levels.

There are a handful of reasons for travel dehydration, and understanding why this problem happens is the first step in remedying it.

Apparently, research shows that the conditions of an airplane can lead to 1.5-2 litres of water loss in a 10-hour flight despite water intake.

While the aircraft cabin is highly controlled, it's still subject to shifts in altitude. Aircraft tend to have low air pressure, which contributes to dehydration by necessitating increased breathing.

Cabin air is dryer than the Sahara Desert. Seriously. You can expect a typical passenger aircraft to have about 12% humidity. The Sahara sees about 25% humidity. It has to be this way; to support a more comfortable humidity level, the aircraft would have to carry gallons of heavy water, and would be at risk for condensation which can be damaging to the parts of the aircraft.

Most people don't even drink enough water when they're at home, let alone on travel days, and decreased fluid intake doesn't just come from the (lack of) water



US energy agency revises oil price forecast up for 2022

he US Energy Information Administration (EIA) has revised up its 2022 forecast for global crude oil prices amid "heightened levels of uncertainty" resulting from a variety of factors, including Russia's full-scale invasion of Ukraine.

In the June Short-Term Energy Outlook (STEO), the EIA on Tuesday revised up the price of Brent crude to an average of \$107.37 per barrel and American

benchmark West Texas Intermediate (WTI) to \$102.47 a barrel in 2022. These figures were 103.35 and 98.20, respectively, in last month's report.

In 2023, the agency predicts that Brent will decline to \$97.24 per barrel, while WTI is projected to fall to \$ 93.24 a barrel.

However, the EIA cautioned that the price forecast is "highly uncertain," driven by a range of factors including how sanctions affect Russia's oil output,

the production decisions of OPEC+, and the rate at which US oil and natural gas producers increase drilling.

The agency also pointed to other key uncertainties expected to affect prices, including the impact and pace of sanctions on Russia, potential new sanctions, the pace of petroleum demand growth through the summer, and the potential for demand to decline because of high retail fuel prices.

According to the statistics agency, the ongoing impact of the coordinated release of petroleum supplies from strategic reserves in the US and Europe, geopolitical uncertainties in Libya and Yemen, along with potential new developments on an Iran deal will also be important for oil price formation in the coming months.

T h e agency forecast that Russia's production of total liquid fuels would decline from 11.3 million barrels per day (bpd) in the first quarter of 2022 to 9.3 million bpd until the end of next year.

Noting that the EU will impose a crude oil import ban in six months and a petroleum product import ban in eight months, the agency said the possibility that these sanctions

The agency the council is currently faced with. According to Selgado, over the past couple of months, the council has been finding it very difficult to meet its payroll and other obligations. That led the council to seek guidance from the Ministry of Labour and Local Government who Selgado claimed had advised them to cut staff by a whopping 50%. While Selgado said that the council had delayed as much as possible, in the end, they eventually had to proceed, but not by the entire amount that they were initially advised to let go.

The Mayor also deflected comments made in the public that the termination of the

14 staff members was politically fuelled. He said that it was not the case and instead claims that the terminations were triggered by the tough financial situation that he had acquired the council under. Selgado said that when he took over the Punta Gorda Town Council he allegedly found the council saddled in debts including a ballooning social security bill that was left by the previous council.

Apart from trying to meet those bills and also having their subvention cut, Selgado said that the residents of Punta Gorda Town are refusing to pay their taxes, despite being notified. This, according to Selgado,

has plunged the council into deeper financial woes and now he is asking the residents of Punta Gorda to pay their taxes so that the council does not have to resort to terminating additional staff.

Minister responsible for Labour and Local Government Oscar Requeña confirmed that while the ministry did meet with the council to discuss their financial situation he claimed that at no point did the ministry ever suggest that the council cut their staff by half. Requeña said that the meeting was centered around finding solutions for the council to improve their revenue collection, implement cost-saving measures and reduce their expenditures.





How does soap kill germs?

T wenty seconds of scrubbing with soap is one of the best ways to protect yourself — and the people and things you touch from disease-causing germs. But how exactly do soapy suds kill pathogenic bacteria and viruses that infect us?

Soap's germ-zapping superpowers are built into its molecular structure: a "head" attached to a long "tail," according to Dr. Lee Riley, a physician, professor and chair of the Division of Infectious Disease and Vaccinology at the University of California (UC) Berkeley. The head is hydrophilic, or water-loving, while the tail is hydrophobic — water-fearing or water-repelling. That hydrophobic tail has an affinity for fats, and all bacteria and some viruses — including SARS-CoV-2, the coronavirus that causes the disease COVID-19 — have a lipid membrane, which leaves it vulnerable to a soap molecule's fat-puncturing tail.

"The tail inserts itself into the [bacteria's] lipid membrane, and that's how it ends up getting killed," Riley told Live Science.

Some types of pathogens have very robust cell walls, so they can survive even after soap's hydrophobic tail penetrates their membrane. But even in these cases, soap molecules can vanquish bacteria and viruses by surrounding and isolating them.

When soap attacks these pathogens, the tails in soap molecules attach to the cell's lipid membrane, with the hydrophilic heads facing outward. This forms a tiny ball of soap molecules, known as a micelle, around the pathogen, Dr. John Swartzberg, a physician, clinical professor emeritus and infectious disease expert at UC Berkeley told Live Science. Bacteria or viruses are easily captured by micelles because the outside of the micelle is hydrophilic, so it's easily swept off your hands and down the drain — along with its pathogenic prisoners — when you rinse the soap away with water.

In 2010, researchers evaluated the effectiveness of soap by having 20 volunteers contaminate their hands a total of 480 times with diarrhea-causing bacteria. The subjects were then randomly assigned to perform one of three actions: wash their hands with

eliminating and annihilating the germs on our hands that antibacterial soap is completely unnecessary and can be harmful; by driving the evolution of antibiotic-resistant strains of bacteria, Swartzberg said. And when we wash antibacterial soap down the drain, it



soap, wash their hands with only water, or not wash their hands at all. Their hands were then tested for the diarrhea-causing bugs, the scientists reported in The International Journal of Environmental Research and Public Health.

In the group of subjects that did not wash their hands, the bacteria were present in 44% of the participants. In those who washed their hands with water alone, bacteria were present in 23% of the study subjects. And in the group that washed their hands with soap and water, bacteria were detected in just 8% of the people, according to the study.

Soap molecules are so effective at

can promote the rise of antibiotic-resistant bacteria in the local water supply.

On top of that, antibacterial soap kills all bacteria — even the good ones that we depend on to keep us healthy, Riley added.

One key component required for soap to do its job is often overlooked, however. And that's time. It takes at least 20 seconds for the tail end of the soap molecule to sufficiently bind itself to the pathogens on your hands or on another surface. Cutting that time short could mean missing out on the full protective effect of using soap, Swartzberg said.



APEB is recognized by the Central Building Authority (CBA) of Belize and is in good standing with the Pan American Union of Engineers Associations (UPADI). Professional engineers need to be registered with APEB, to be licensed to certify engineering drawings and designs. The Association is tasked with vetting the academic qualifications and work experience of engineers who apply to ensure they maintain a proper code of ethics, standards, and the integrity of the profession. Failure to comply with the Act can lead to fines and even imprisonment.

NADO trains Andi-Doping Control officers

Belize has enhanced its capacity to enforce world controls against the use of performance enhancing substances in sports, when the National Anti-Doping Organization (NADO) trained 16 new doping control officers in a seminar at the Marion Jones Sporting Complex in Belize City on Friday and Saturday, July 1-2.

The six women and 10 men were certified to highest standards of the World Anti-Doping Agency (WADA), after completing the hands-on training conducted by Dr Paulina De La Loza of the Mexican Regional Anti-Doping Organization (MEX-RADO) and technician Paula Diaz of the Panama Regional Anti-doping Organization (PAN-RADO). This sets a new level of anti-doping controls that Belize will have at any sporting event, as typically there may be only four or five control officers for an entire tournament. Belize now has enough control officers for a one-to-one ratio to the athletes who may be randomly selected for testing after an individual event.

Testing athletes for banned substances becomes especially important for tournaments where the best athletes may go on to represent Belize in international competitions. Diaz instructed the doping control officers how to record the athlete's information on the international forms which will be submitted to the laboratory along with the sample, most importantly the date and time the sample was taken. They learnt the theory and practice of safely collecting uncontaminated samples of body fluids, urine and blood, from the athletes immediately after sporting events. The control officer must accompany the athlete from the competition venue to the sampling facility and may not leave the athlete's side, until the athlete has produced a sample for testing. This may require a wait of several hours until the athlete is able to urinate freely to produce the required volume of sample, at least 90 milliliters, or a more ample 110 milliliters. The athlete must always be given a choice of at least three sealed sample containers in which to place their sample, Dr. De La Loza explained. This is to avoid any suggestion that the athlete was deliberately given a container which was already contaminated. The doping control officer must allow the athlete to verify that the packaging of the sample container is sealed, and once athlete selects a container, the control officer must not touch the container until the athlete has placed his sample in the container and sealed it. Once the container is sealed, it is safe for the control officer to place the container back in the packaging to be shipped to the laboratory for testing. The seals are such that only the laboratory is equipped to safely open the sample container. The lab will not test the sample if there is any evidence the seal has been tampered with. The control officer is required to have at least one witness or observer present when the sample is taken, to verify that the proper protocols are followed. An athlete is also required to give a complete list of any medication or training supplements that they may be taking, which may mask a proper test result or give a false positive test for a banned substance. The trainers also offered a list of substances and medications which an athlete should not be taking before competition, as a simple cough syrup may contain drugs which would lead to a positive result for a banned substance.




